OFFICIAL RULES

2013 Makes-Me-Wanna SHOUT! Pie Baking Challenge Contest

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED.

APPLICATIONS MUST BE RECEIVED ON FEBRUARY 4, 2013, 11:59 PM ET

- 1. Eligibility: The 2013 Makes-Me-Wanna SHOUT! Pie Baking Challenge Contest ("Contest") is open to residents of the Washington, DC Metropolitan Area, which is comprised of the District of Columbia and the selected counties listed below in Maryland, and Virginia * only, who are amateur cooks aged 18 years or over as of January 1, 2013. Applicants must have resided in one of the above areas for a minimum of six months prior to their Contest entry. Food Professionals, such as chefs, pastry chefs, or food home economists who create recipes for pay, are not eligible to enter or win. Employees or relatives of any of the Sponsor organizations, companies, or any of their respective parents, subsidiaries and affiliated companies, and their immediate family members (including parents, children, siblings, spouses, regardless if they live in the same household) or individuals in the same household of such employees (regardless of whether related or not) are not eligible to participate in the Contest or receive a prize. First prize winners of any prior Makes-Me-Wanna SHOUT! baking challenges or baking contest presented or produced by the sponsoring organizations and companies are not eligible to enter or win.
- 2. **How to Enter**: Create your own dessert pie recipe (cobbler, deep dish) made from scratch (No commercial mixes, pie fillings, pre-made or pre-baked pastry/crusts allowed.), which must include a minimum of one (1) cup of flour (your "Recipe") and must be baked by the entrant. To enter your Recipe into the Contest, complete a Contest application form, available at **www.shoutbakingchallenge.com** and include the Recipe and a pie story or baker's statement related to your pie. Recipes must be typed, list all the ingredients, quantities, and the instructions for preparation of the pie. Applications must include a pie story or baker's statement regarding the pie which must be non-fiction, typed, and 250 words or less, no exceptions (your "Story"). You may want to share a special memory, the story of making the pie, why you bake, or your

story about a person or people who enjoy your pie. Include your complete name and address on the Recipe and also include all other requested information in the application. Then, submit the completed application, including your Story and your Recipe between 9:00 a.m. ET November 4, 2012and 11:59 p.m. ET on February 4, 2013 ("Contest Entry Period") following the Entry Guidelines below**, in one of the following ways:

- (a) MAIL submit your entry by U.S. Mail to Shout Baking Challenge 2013, c/o Michon Boston Group Ltd, P.O. Box 21204, Washington, DC 20009 by providing the requested information including the completed application, Recipe, and Story please note, all mail-in entries must be postmarked by **February 4, 2013**, and received by **February 6, 2013** to be considered; or
- (b) ONLINE visit the website at www.shoutbakingchallenge.com and enter online by completing and submitting the online application with your Recipe and Story included during the Contest Entry Period;

or

(c) FAX - fax your entry to 1-866-587-9790 during the Contest Entry Period, including the completed application, Recipe, and Story with your name and contact information including your phone number on each page included in your fax.

Once the entry has been submitted, entrants will not be permitted under any circumstances to submit substitutions and/or new versions of their entries. Limit one entry per person. Incomplete or illegible entries, entries without a signature or not including birth date will not be honored. Stories and recipes will be posted online at http://www.shoutbakingchallenge.com.

Sponsors are not responsible for late, lost, damaged, mutilated, illegible, stolen, incomplete, misrouted, misdirected, or postage due entries or mail or for address or email address changes of entrants. Entries that are mutilated, incomplete, defective, altered, illegible, irregular in any way or not in full compliance with the Official Rules are void. Entries become the property of the Sponsors and will not be returned. Entries

must be submitted during the Contest Entry Period and received by 11:59 p.m. ET on February 4, 2013, except that mail-in entries must be postmarked by February 4, 2013, and received by February 6, 2013. * For purposes of the Contest, the following cities and counties are considered the Washington DC Metropolitan area: District of Columbia; Maryland (Calvert County; Charles County; Frederick County; Montgomery County; Prince George's County; Anne Arundel County; Howard County; St. Mary's County); Virginia (Alexandria County, Arlington County, Clarke County, Fairfax County, Fauquier County, Frederick County; Loudoun County; Prince William County; Spotsylvania County; Stafford County, Warren County).

**Entry Guidelines: Your Recipe and Story must (1) be completely original; (2) be solely created by the entrant; and (3) not infringe the rights of any third party, including, but not limited to copyrights, patents, trademarks, trade secrets, and rights of publicity/privacy. Entries must be in the English language. Sponsors reserve the right to eliminate any entry that does not adhere to the Entry Guidelines or the terms and conditions of these Official Rules, uses inflammatory or derogatory language, or that is lewd, obscene, pornographic or disparages Sponsors, or that are otherwise inappropriate at Sponsors' sole discretion, and any such entry may be disqualified.

3. Public Voting, Judging and Winner Notification:

FIRST ROUND: On or about **March 8, 2013**, Sponsors will select and notify the top twelve (12) entrants to be Semi-Finalists by email, telephone, or mail at the email address, telephone number, or mailing address provided with the entry. Entries will be judged in the First Round based on the following criteria: Apparent viability and originality of recipe (50%) and execution and creativity of the Story (50%). In the unlikely event of a tie, winner as between the tied entrants will be selected based on the tied entry with higher score in the viability and originality of recipe category. Sponsors

reserve the right to reduce the number of Semi-Finalists in the event there are not sufficient or appropriate entries in its sole discretion. Semi-Finalists must be prepared to bring their pies/samples to Miriam's Kitchen for the People's Choice Second Round on March 23, 2013.

SECOND ROUND: The First Round Semi-Finalists will be asked by Sponsors to participate in a special Second Round competition event of judging on March 23, 2013 at Martha's Table in Washington, DC ("Second Round Event"). Semi-Finalists must make, bake, and assemble their entries, and bring fully baked, unsliced pies (enough for 150 samples) to Martha's Table, located at 2114 14th Street, NW, Washington, DC 20009 on March 23, 2013 at a TBD time to participate in the Second Round, and must be present during the Second Round Event. Attendees of the Second Round Event will be asked to judge the Semi-Finalists pies by considering taste, consistency, and originality (the "People's Choice Vote"). Any individual who, at the sole determination of the Sponsors, abuses the voting process in any way, will be disqualified from further voting in the Contest and his/her prior votes may be disqualified. Sponsors are not responsible for lost, late, incomplete, invalid, unintelligible or misdirected votes, which will be disqualified. Sponsors may at their sole discretion disqualify votes that appear to be fraudulent, false, or otherwise not in accordance with these rules. One (1) of the Five (5) Finalists in the Second Round will be selected by attendees or "Peoples Choice" (100%) taking into consideration taste, consistency, and originality. remaining Four (4) Finalists in the Second Round will be selected by the official judges based on the following criteria: official judge's discretionary judging (100%) taking into consideration taste, consistency, and originality. In the unlikely event of a tie, the winner as between the tied entrants will be selected based on the tied entry with the higher score in the official judge's category. Finalists will be publicly announced on site at the Second Round Event. Finalists must be prepared to bring their pies/samples to Eatonville Restaurant in Washington, DC for the Final Round on April 23, 2013.

Public Voting in Second Round. The public will be invited to purchase tickets to the Second Round competition online and at Martha's Table on March 23, 2013, from 1:00 p.m. ET through 4:00 p.m. ET and ticket holders will be able to participate in the People's Choice voting.

FINAL ROUND: The Second Round Finalists will be asked by Sponsors to participate in the Final Round competition event of judging on April 23, 2013 at Eatonville Restaurant in Washington, DC ("Final Round Event"). Finalists must bring a fully baked, unsliced pie to Eatonville Restaurant, located at 2121 14th Street NW, Washington, DC 20009 on April 23, 2013 between the hours of 4 p.m. ET and 6 p.m. ET, and must be present during the Final Round Event. Finalists must make, bake, and assemble their final entry pie. The winning entry will be selected based on the following criteria: (1) taste and consistency of the pie (50%); (2) appearance (30%), (3) originality (10%); and (4) Story behind the pie (10%). In the unlikely event of a tie, the winner as between the tied entrants will be selected based on the tied entry with the higher score in the originality category. All Finalists will be judged by the judging panel, which will include Eatonville Restaurant Owner Andy Shallal, and other judges selected at Sponsors' sole discretion, whose decisions are final on all matters relating to the Contest. The winner will be notified by public announcement on site at the Final Round Event. The Judges will select the top three entries during the Final Round Event.

Entrants must strictly follow the recipe submitted with the original entry when making, baking, and assembling a pie for the Second Round Event and for the Final Round Event. Sponsors or their agents may test bake and assemble pies from the recipes submitted by entrants to confirm compliance with this requirement, and may disqualify as noncompliant any entry for which there is a materially different result, in Sponsors' sole discretion, between entrant's pie presented during the Second and/or Final Round Event and the result of Sponsors' test bake of the recipe submitted by entrant.

All Entrants may be required to complete and sign an affidavit of eligibility, liability/publicity rights releases, and a license of all rights concerning the recipe, instructions, and Story in the entry, including copyrights, to be received by Sponsors within seven (7) days of the date of first attempted request for such documents to be completed and signed ("Request"), or entrant will be disqualified. Return of any semi-

finalist, finalist, or winner notification or prize as undeliverable will result in disqualification and selection of an alternate winner. If any semi-finalist, finalist, or winner cannot be contacted at the email address or phone number provided at the time of entry, is contacted and does not respond as directed within seven (7) days of attempted notification, refuses the prize or is ineligible to accept the prize, the prize may be forfeited and awarded to an alternate semi-finalist, finalist, or winner. All prizes claimed in accordance with the Official Rules will be awarded. Winner may be required to provide a U.S. shipping address to claim prize.
